Dear Secretaries of State,

Firstly, may we congratulate you on your appointments as Secretary of State for Environment, Food and Rural Affairs and Secretary of State for Energy Security and Net Zero, respectively.

We are writing to you as the Environmental Policy Forum (EPF), a coalition of 14 professional bodies and learned societies promoting environmental sustainability and resilience for the public benefit. Collectively we represent over 110,000 qualified professionals across a wide range of different specialised disciplines, often working in industry or the public sector and many running successful businesses.

Ten priorities for a better environment

The UK faces inextricably linked climate and nature crises and the successive recent governments have failed to adequately tackle these challenges. In advance of the general election, the EPF set out ten clear priorities for the new government to achieve with support from business. Demonstrating

cross-sector consensus on both the level of action required and the opportunities this presents to the UK, including for growing to a healthier and sustainable economy, these priorities are as follows:

Cross-cutting priorities

- 1. Improve environmental governance to ensure effective policy delivery.
- 2. Unlock the enormous social, economic and environmental potential of green jobs and skills.
- 3. Take a holistic approach to land use.

Thematic priorities

- 4. Ensure soils are treated as a valuable resource.
- 5. Deliver on our 30x30 commitment to reverse biodiversity decline.
- 6. Transform the UK agricultural and food system, to secure the UK's access to sustainable sources of food.
- 7. Prioritise water resilience to deliver 'A Fresh Water Future'.
- 8. Increase ambitions and holistic action for a country with cleaner air.
- 9. Deliver a truly circular economy.
- 10. Unlock investment in low carbon technologies to deliver net zero.

These priorities are interconnected, reflecting the urgent need for a joined-up approach to policymaking, involving effective communication and coordinated policy across DEFRA, DESNZ and all other government departments. This holistic approach should be underpinned by evidence-based policy and regular consultation with experts, to enable effective policy delivery.

A positive start

There is much to welcome in the new government's policy agenda when it comes to delivering on these priorities, including the commitments outlined in the King's Speech and the Labour Party manifesto and missions. As just a few notable examples, it's great to see the government commit to investing in green jobs, skills and renewable energy, introducing a Land Use Framework and strengthening the powers of water regulators.
